The bids will be opened in the presence of Bidders' representatives who choose to attend at **26th mangsir, 2076 B.S. 2:00 PM at the office of Rural Municipal Executive, Joshipur**. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of **Rs. 39,000 [Rs. Thirty Nine Thousands only]**, which shall be valid for 30 days beyond the validity period of the bid.
