Bids received after this dead line will be rejected.
5. The Electronic bids will be opened in the presence of Bidders' representatives who choose to attend on 13:00 Noon of 1<sup>st</sup> Nov.2022 (2079/07/15) at Office Of the Rural Municipal Executive (JRM), Joshipur, Kailali
6. Electronic Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting Prescribed in the following table which shall be valid for 30 days beyond the validity period of the bid.
